I hereby give notice under Sub -section (1) of Section 07 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land required for construction of Water Tank and Quarters under the Anuradhapura North Water Supply Project.

Description of the land to be acquired:-

An allotment of land called Pihimbiyagollawa Mookalana, Kolongahawatta in total extent of 0.2023 Hectare depicted as Lot No. 228 in Final Village Plan No. 580, prepared by the surveyor - General in the village of Pihimbiyagollawa in Grama Niladhari Division of No.81 Pihimbiyagollawa, in Divisional Secretary's Division of Rambawa, Anuradhapura District Northern Central Province and bounded as follows :-
