I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government intends to acquire the following land which is required for a public purpose.

*Description of the Land to be acquired :*

The allotment of land called "Kongahamulawatta" in total extent of about 0.0334 Hectares, depicted as Lot No. 1 in Preliminary Plan No. Ku 2374, dated 06.07.2017, Surveyed and prepared by the Surveyor General, situated at the village of Theliyagonna, in Mallawapitiya Grama Niladhari Division of No. 711, in the Divisional Secretary's Division of Mallawapitiya in Kurunegala District, North Western Province and bounded as follows.
