Provincial Councils Notifications

EASTERN PROVINCE PROVINCIAL COUNCIL

HEREBY publish the regulation enacted under sub clause 11 (8), Eastern Province Road Passengers Transport Service Authority Audience No. 02/2009 of Eastern Provincial Council.

These regulations shall be effective from 01st September 2017.

Regulations

01. These regulations are introduced as “Passenger Transport Regulation for taxi vans, No. 01, 2017” of Eastern Province Road Passenger Transport Authority and will be effective from day of 01st Month September 2017.
02. On hired basis with fees charged, separately or in groups without the permission of Eastern Province Road Passenger Transport Authority or registration from 01.03.2017 should not be engaged in Passenger Transport.
03. A permit shall not be issued to individual other than a registered owner of the taxi van.
04. When issuing a permit the priority should be given to resident of the Local Administrative Division of the relevant authority.
05. The Authority reserves the right to issue a permit, to renew or to transfer a taxi van from one vehicle part to another or to reject such request.
 - 05.1. When using the discretion the following matters shall be considered.
 - (a) The taxi van executed from the relevant vehicle park how long the requirements of the passenger transport is fulfilled.
 - (b) If requirements of passenger transport is fulfilled from the vehicle park executed presently. is it appropriate to issue a new permit for the said place.
 - (c) The authorized area for a taxi van park should be decided and un operated taxi van from that parks should be included to the quantity of hired van relevant to that place.



06. When obtaining a permit, renewing or changing or amending when it is for the registered owner or a society / company or an organization the authorized officer should submit the application within a month. With the same application the following documents and fees (schedule-4) should be submitted.

- 6.1. A certificate or a copy of the certificate issued by Commissioner General for Motor Traffic including registration details or the registration certificate of that van.
- 6.2. Insurance certificate which covers complete and unlimited. Insurance cover for all the passengers travel in the hired van and the third party.
- 6.3. Annual revenue license or a photocopy.
- 6.4. Medical Certificate or a photocopy whereof regarding the driver.
- 6.5. When it is for renewing a permit, the permit book.
- 6.6. The note included fees defined by the authority.
- 6.8. Membership certificate of taxi van runner's society / company by authority or issued by the organization.

07. The permit shall be according to the second schedule.

08. Permit label (Windscreen label) should be according to the third schedule.

09. The hire fees system defined by the authority should be according to the fourth schedule.

10. Every application for passenger service permit should be submitted in a period less than a month expect by the application before the cancellation of the said permit.

11. The permit included the following terms and conditions.

- 11.1. The permit is not transferable.
- 11.2. if otherwise stated in the permit, the permit will be in force for twelve months period from the date of issued.
- 11.3. The Original copy of the permit and the label should be kept in the van by the driver.
- 11.4. The permit label issued by the authority should be displayed on the left side of the windscreen of the van.
- 11.5. Permit holder and his employee should maintain the van used for rendering the relevant service in good mechanical conditions and with clean condition.
- 11.6. In addition to these regulations the responsibility of the permit holder and the responsibilities of the driver of the hired van are considered the terms and conditions of the permit.

12. Documents which should be displayed and kept in the hired van.

12.1. Documents should be kept in the van by the driver.

- (a) Original copy of the permit and the label.
- (b) The medical certificate of the driver.
- (c) The system of fees of taxi van approved by the authority.
- (d) Things should be carried under Motor Traffic Ordinance.
 - i. Revenue License
 - ii. Insurance Certificate
 - iii. Driver License

12.2. Things should be displayed –

- (a) Photocopy of the Passenger Service Permit Label of taxi van.
- (b) Notice expressing smoking is prohibited within the van.
- (c) Notice depicting due fees system.
- (d) The registration number of the taxi van and the permit number issued by the authority.

13. The responsibilities of permit holder.

- 13.1. The permit holder should run his van subject to the conditions of the taxi van society / company or organization accepted by the authority
- 13.2. When the taxi van subjected to an accident it should be informed to the authority within seven days through hired van society company.
- 13.3. Regarding a serious or fatal accidents the hired van should not engaged in the service until new appropriate certificate is obtained.
- 13.4. A driver who perpetrated a serious or fatal vehicle accidents should not engaged service until he is certified to be in proper physical condition (by serious accident meant that as the research of the accident a injured person under treatment in hospital exceeding seven days or a damage to the property exceeding Rupees Ten Thousand. The accidents where four Wheels went out of the road are considered serious accident. By fatal accident it is meant that the subjected person died by the result of it.,

14. Responsibility of the driver:-

- 14.1 Taxi van should be driven as to certify the safety and convenience of all passengers travelling in the van.
- 14.2 The van should not be driven with exceeding the approved quantity of passengers.
- 14.3 Should be in good conduct and good character and should be courteous to the passengers, government and other officers.
- 14.4 Should not be under the influence of liquor and drugs when engaged in service and within the service time should not take liquor or drugs.
- 14.5 Should not drive uncaringly, in disregard and dangerously the taxi van.
- 14.6 The driver should be registered in authority.
- 14.7 The taxi van should not be parked obstructing the vehicle park expect within the due place in the taxi van park.
- 14.8 Always engaged in the service taxi van should be dressed an uniform of official identity card defined by the authority.
- 14.9 In an occasion when the taxi van could not travel to the destination of the passenger or into any reason of accident/ mechanical defect or unavoidable circumstances the fees could be charged only to the place that accident/ mechanical defect occurred. In such instance every effort should be taken to give a optional way of transport to the passengers.
- 14.10 Should not charge more or less amount than the approved fees of the authority from any passenger.
- 14.11 Anybody should not be allowed to smoke in the van.

15. The responsibility of the passengers :-

- 15.1 Within the taxi van, should not smoke or take liquor.
- 15.2 Should conduct politely within the hired van.

16. Regulations for taxi van runners organization:

- 16.1 A registered taxi van runners society/ company or organization registered under company ordinance act or corporative ordinance act administrative ordinance act should be in every provincial administration authority.
- 16.2 The responsibility of said society/ company or organization is to examine the runners carryout the conditions of these regulations.
- 16.3 Regulations for the execution of matters in these regulations should be included into the statistics of that society/ company or organization.
17. Regulations for the vehicle park of taxi van:-
- 17.1 The authority could put up hired van vehicle parks with the agreement of provincial administrative institutions.
- 17.2 The hired van societies/ companies or organizations should managed the organization of said parts under the condition enacted by the authority.
- 17.3 Vehicle park fees due to provincial administrative institutions should be take by the said societies/ companies or organizations.
18. The breach of regulations by the taxi van drivers is regarded as the breach of regulations by the permit holder. But in case of the drive is registered in taxi van driver authority the permit should not responsible.
19. The hired van fees should be charged according to the taxi van fees defined by time to time by the authority.
20. When a permit holder submitted an application for the renewal of a permit issued by under this ordinance the permit holder.
- 1) That the terms and condition of this ordinance and regulations made under it has been followed,
 - 2) Under this ordinance or under the regulations made under it not been convicted,
 - 3) All due fees to be take to the authority have been paid and when it is satisfied that the other relevant conditions have been fulfilled that permit could be renewed from the validity expiry date of that permit for a one year period or a period less than that.
21. Any individual who violate default or neglect this regulations will be convicted for offence and he/ she will be subject to the procedure under clause 44 of Eastern Province by Road passenger Transport Authority Ordinance No. 2, 2009.
22. In an investigation conducted by officer/ officers authorized by the authority or investigation team or teams under schedule 5, when the party with accepts that the regulations have been dressed, the authority has the power to take following procedures.
- 1) To take signatures for a statement that the breach of regulations which disclosed in an investigation will not be done hereafter or will be rectified.
 - 2) To charge amount stated in schedule 5 for breach of regulations and other expenses on investigation or administrative expenses.
 - 3) The authority has the power not to indict or to maintain a case under clause 44 of 11 (4) Ordinance of Eastern province Road Passengers Transport Authority, No. 2, 2009 against the permit holder when the permit holder agress comply above (I) and (II).
23. Any permit holder cannot transfer the possession of the permit to another person on his discretion. If such transfer is done it is not valid. Although, when the authority intents to fullfill the passenger demand required, the possession of the permit could be transferable.
24. The authority issue instructions regarding the procedure should be followed by accepted societies companies or organization regarding the management of hired van. Accordingly, the authority can issue instructions regarding the reports should be supply to the authority and maintenance.
