REGULATIONS made by the President under Section 155 read with Section 29 of the Army Act (Chapter 357), read with Article 4 of the Constitution of the Democratic Socialist Republic of Sri Lanka and Section 51 of the Nineteenth Amendment to the Constitution.

Regulations

The Army Pensions and Gratuity Code 1981 published in *Gazette Extraordinary* No. 562/11 of June 15, 1989 as amended from time to time is hereby further amended as follows :-

- (1) in regulation 19, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :-

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Army Medical Board, to be attributable to military service or to the performance of non-military duties under Section 23 or 23A of the Army Act, the aggregate amount of the pension so awarded to an officer or in respect of an officer, together with the Army Service Pension, if any, shall not exceed 100% of pay per annum.”.

- (2) in regulation 28, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Army Medical Board, to be attributable to military service or to the performance of non-military duties under Section 23 or 23A of the Army Act, the aggregate amount of the pension so awarded to a soldier or in respect of a soldier, together with the Army Service Pension, if any, shall not exceed 100% of pay per annum.”.

The Navy Pensions and Gratuities Code 1981 published in *Gazette Extraordinary* No. 654/10 of March 20, 1991 as amended from time to time is hereby further amended as follows :-

- (1) in regulation 16, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :-

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Navy Medical Board, to be attributable to Naval service or to the performance of Naval duties under Section 21 of the Navy Act, the aggregate amount of the pension so awarded to an officer or in respect of an officer, together with the Navy Service Pension, if any, shall not exceed 100% of pay per annum.”.

- (2) in regulation 25, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :-

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Navy Medical Board, to be attributable to Naval service or to the performance of Naval duties under Section 21 of the Navy Act, the aggregate amount of the pension so awarded to a sailor or in respect of a sailor, together with the Navy Service Pension, if any, shall not exceed 100% of pay per annum.”.

The Air Force Pensions and Gratuity Code 1981 published in *Gazette Extraordinary* No. 645/8 of January 16, 1991 as amended from time to time is hereby further amended as follows :-

- (1) in regulation 16, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :-

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Air Force Medical Board, to be attributable to Air Force service or to the performance of Air Force duties under Section 23A of the Air Force Act, the aggregate amount of the pension so awarded to an officer or in respect of an officer, together with the Air Force Service Pension, if any, shall not exceed 100% of pay per annum.”.

- (2) in regulation 25, by the insertion immediately after sub-paragraph (a) of paragraph (1) thereof, of the following proviso :

“Provided however, where such disablement or death, if caused by terrorist activities, is certified by an Air Force Medical Board, to be attributable to Air Force service or to the performance of Air Force duties under Section 23A of the Air Force Act, the aggregate amount of the pension so awarded to an Airman or in respect of an Airman, together with the Air Force Service Pension, if any, shall not exceed 100% of pay per annum.”.
