**Regulations of the Sri Lanka Institute of Architects**

REGULATIONS made under Section 6(1) of Section 6(2) read with Sections 3, 4, 7 and 9 of the Sri Lanka Institute of Architects Law No. 1 of 1976 as amended by Sri Lanka Institute of Architects (Amendment) Act, No. 14 of 1996.

1. Regulation 1.2 of the regulations published in *Extraordinary Gazette* No. 2041/18 of October 17, 2017 is hereby repealed and replaced with the following new regulation :

**Regulation 1.2**

The “Practice of Architecture” is the rendering of professional services relating to the holistic planning and designing of the built environment in terms of form, space and ambience to reflect functional, technical, social,



environmental, cultural and aesthetic considerations. It requires the creative manipulation and coordination of materials and technology. This includes but is not limited to the design of the interior, exterior, the landscape, the externals, the layouts, their manipulation in terms of scale, texture, colour, light and shade and includes restoration, refurbishment, retrofitting and conservation of individual buildings or groups of buildings incorporating natural elements or landscapes. The practice of Architecture also encompasses aspects of realizing buildings and structures, management, administration of projects and inspection of construction and documentation which includes drawings and specifications and other technical inputs.

The practice of Architecture shall be carried out solely by persons and entities qualified in Architecture registered with the Architects Registration Board.

2. Insertion of new regulation 7.4.2 (2) (c) to the regulations published in *Extraordinary Gazette* No. 2041/18 of October 17, 2017.

**Regulation 7.4.2 (2) (c)**

In the event of inability of the Immediate Past President to carry out the functions of the office as Immediate Past President due to ill health, death or being unavailable for a period exceeding six (6) months, a member of the College of Past Presidents who does not hold a formal office at the Sri Lanka Institute of Architects shall be appointed by the Council as the “Past President in Council” and shall hold office for the unexpired period of term of office of the Immediate Past President whom he succeeds.
