THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted as Lots 'A', 'B', 'C' and 'D' in extent of 1.2448 Hectares in the Advance Tracing No. KE/YTY/2016/258 and dated 14.09.2017, prepared by the Surveyor-General, situated in the Village of Kithulgala in the Grama Niladhari Division of No. 34B of Kithulgala South in the Minor Division of Kithulgala in the Divisional Secretary's Division of Yatiyantota in Kegalle District, Sabaragamuwa Province and bounded as follows:

01. **Lot 'A' – Ahaslena Watta – Extent: 0.5385 Hectare**
North: Kelani River; East: Ahaslena Watta; South: Lot B (Road);
West: Ahaslena Watta.

02. **Lot 'B' – Ahaslena Watta – Extent: 0.0387 Hectare**
North: Lot A and Ahaslena Watta; East: Road and Ahaslena Watta;
South: Lot D (Road) and Lot C; West: Ahaslena Watta and Road.

South: Road, Ahaslena Watta and Lot C; West: Lot C.
