THE LAND ACQUISITION ACT (CHAPTER 460)

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, No. 28 of 1964 (Amendment) that the Government intends to acquire the following land which is required for a public purpose.

Description of the land to be acquired:

Four (04) allotments of land in total extent 0.0847 Hectare depicted as lot no. 232, 233, 236 & 237 in the Sheet No. 09 of Block No. 01 in Cadastral Map No. 810019 prepared by the Surveyor General situated in the Village of Maligaspe in the Grama Niladhari Division No. 101E of Maligaspe, within Municipal Council limit of Galle Divisional Secretary's Division of Four Gravets, Galle District of Galle, Southern Province. The names, extent and boundaries of the said allotments of land are as follows:
