**ORDER UNDER SECTION 2 (1) OF THE LAND GRANT
(SPECIAL PROVISIONS) ACT, No 43 OF 1979**

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms do hereby rescind and declare the Schedule below, in terms of the power under Section 18 of the Interpretation Ordinance, as it is observed that an administrative error has been occurred by the *Gazette* Notification mentioned below due to the decision to grant the persons called Arjun Indrajith Gunarathne and Amitha Lal Gunarathne, two children of the deponent of the file Co/ 1362 as a release of a primary legal obligation of the Land Reform Commission and handing them over the possession of the allotment of land described in the Schedule below, declared by the publishing date of the *Gazette* Notification No. 180/ 5 dated 17.02.1982 under the aforesaid Act and the Section, by Mr. Lionel Gamini Dissanayake, precedent Minister of Land and Land Development by virtue of powers vested under Section 2 (1) of the Land Grant (Special Provisions) Act, No. 43 of 1979.
