**THE LAND ACQUISITION ACT (CHAPTER 460)**

**Notice under Section 7**

I hereby give notice, under Sub - section (1) of Section 7 of the Land Acquisition Act, as Amended by the land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude\* which is required for a public purpose:

*Description of the land or servitude to be acquired:*

The land named as Batadombagahawatta in total extent of 0.0010 Hectare (A: 0 R: 0 P : 0.3955) marked as lot No.1 in Preliminary Plan bearing No. B.P.G. 4336 made by Surveyor General situated in the Village of Gonapinuwala, in the Divisional Secretariat Gonapinuwala, District of Galle. The boundaries of the land are as follows:-

North : Road (R.D.A) and Lot No. 57 depicted in Preliminary Plan No. G. 3857; East : Lot No. 57 depicted in Preliminary Plan No. G. 3857 and Batadombagahawatta claimed by P.D.R. Dewasiri and J.A. Wijewickrama; South: Batadombagahawatta claimed by J.A. Wijewickrama,
