THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land indicated in following names and extents depicted in the Advance Tracing No. KE/YTY/2017/165 and dated 12.01.2018, prepared by the Surveyor General, situated in the Village of Kalukohutenna in the Grama Niladhari Division of No. 134 D, Kalukohutenna in Minor Division of Kithulgala Palatha of the Divisional Secretary's Division of Yatiyantota in Kegalle District of the Sabaragamuwa Province and bounded as follows:

01. Lot 'A' – Kohila Puranagawa Watta – Extent: 0.0452 Hectare
