#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act. Details of the purpose and land is described in table II.

1. **Description of the purpose:**– For the construction of Access Road to the Dippitiya reservoir of Kandy North and Pathadumbara integrated Water supply project.

2. **Description of the land:**– An allotment of depicted in the Advance Tracing No. Maha/AKR/2016/418 dated 17.04.2017 prepared by the Surveyor-General situated in the Village of Dippitiya, Village at Udagampaha Minor Division in the Divisional Secretary's Division of Akurana in Kandy District of Central Province and bounded as follows:

01. **Lot 'A' – Extent: About 0.0093 Hectare**

North: Road, Saistan Seed Division Estate claimed by S. M. S. Noorul Asmiya and Lot B; East: Lot B; South: Dippitiya-Arambepola
