THE SPORTS LAW, No. 25 OF 1973

REGULATIONS made by the Minister of Sports under Section 41 read with Section 31 of the Sports Law, No. 25 of 1973.

Regulations

Whereas by *Gazette Notification* bearing No. 2073/15 dated 31.05.2018, I Faiszer Musthapa, PC, Minister of Provincial Councils, Local Government and Sports appointed Mr. Hewa Thondilage Kamal Pathmasiri, Secretary of the Ministry of Provincial Councils, Local Government and Sports as the Competent Authority of Sri Lanka Cricket with effect from 01st June 2018 to continue with administration and perform any such other functions necessary for the due administration of Sri Lanka Cricket.

And whereas Sri Lanka Cricket has consequently undertaken to the International Cricket Council, the international Governing body for the Sport of Cricket to appoint an advisory committee to assist and advise the said competent authority in carrying out the administration and perform any such other functions necessary for the due administration of Sri Lanka Cricket until such time an election is held to elect office bearers to Sri Lanka Cricket.

Accordingly, I Faiszer Musthapa, PC Minister of Provincial Councils, Local Government and Sports, in terms of Section 41 of the Sports Law No. 25 of 1973 as amended hereby appoint -

- (a) The Secretary to the Ministry of Provincial Councils, Local Government and Sports as the Competent Authority of Sri Lanka Cricket with effect from 01st October 2018 to continue with the administration and perform any such other functions necessary for the due administration of Sri Lanka Cricket.



- (b) I hereby also appoint five persons of repute as an advisory committee to assist the said competent authority in continuing with the administration and perform any such other functions necessary for the due administration of Sri Lanka Cricket.
- (c) The said advisory committee shall continue to function until such time an election is held to elect office bearers to Sri Lanka Cricket.
- (d) On the death, resignation, removal or other incapacity of a particular member of the said advisory committee, the other members of the said Committee shall function until such time a replacement is named by the Minister in charge of the Subject of Sports.

Gazette notification bearing No. 2073/15 dated 31st May 2018 is hereby rescinded with effect from 29th October 2018.
