**THE LAND ACQUISITION ACT (CHAPTER 460)**

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act No. 28 of 1964, that the Government intends to acquire the servitude over the following Land, which is required for a public purpose:

*Description of the Land/Servitude to be acquired:*
