THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke Minister of Lands and Parliamentary Reforms here by declare under Sub-section (1) of Section 5 of land acquisition Act, that the land describe below is needed for a Public Purpose and will be acquired under the provisions of that Act:
