I hereby give notice under Sub section (1) of Section (7) of the Land Acquisition Act, that the Government intends to acquire the following land servitude which is required for a public purpose.

Description of the land to be Acquired:

An allotment of land is called Kobekatuwehena about 0.3284 Hectare in extent depicted as Lot 01, in P.P.K. Plan Number 3615 and dated 08.10.2018 of preliminary plan made by the Senior Superintendent of Survey and situated in the village of Thambarawa, in the Grama Niladhari Division of No. 44A, Habalakkawa, in the Minor Division of Galbata Korale (West), in the Divisional Secretariat Division of Aranayaka, in the District of Kagalle, in Sabaragamuwa Province. Boundaries are as follows.

01. Lot No. 01

Name of the land: Kobekatuwehena; Extent: 0.3284 Hectare.

Boundaries:

North: Kobekatuwehena and boundary of Bakulwala; *East:* Lot No.4 in preliminary plan K 3573; *South:* Aluthdurayalagehena; *West:* Aluthdurayalagehena and Kobekatuwehena.
