**LAND ACQUISITION ACT (CHAPTER 460)**

**Notice under Section 7**

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the under-mentioned lands which are required for a public purpose.
