THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted in advance tracing Number GA/YKK/2017/1128 and dated 31.10.2017, prepared by Galle District Surveyor General, situated in the Village of Nakiyadeniya in the Yakkalamulla Divisional Secretary's Division in Galle District in the Province of Southern.
