### Provincial Councils Notifications

#### WESTERN PROVINCE PROVINCIAL COUNCIL

**Order under Section 32(2) of Provincial Councils Act, No. 42 of 1987 amended by Provincial Council's (Amendment) Act, No. 28 of 1990 assigning the powers of Western Province Public Service**

I, K. C. Logeswaran, the Governor of Western Province by virtue of powers vested in me under Section 32(1) of Provincial Council Act, No. 42 of 1987 as amended by Provincial Councils (Amendment) Act, No. 28 of 1990, do hereby delegate powers vested in me regarding appointments, transfers, promotions, dismissal from service and disciplinary control of officer of Western Provincial Public Service to the Provincial Public Service Commission in terms of Section 32(2) of the said Act, subject to conditions stipulated in Schedules 01 with effect from 16th April 2018. Powers of appointment to posts in Schedule 02 shall continue to be with the Governor of the Western Province,

Officers aggrieved by the decision of either the disciplinary authority and/or the Provincial Public Service Commission shall have a right of appeal to the Governor.

Delegation of powers published in *Extraordinary Gazette* No. 1859/32 dated 24.04.2014 is hereby repealed without prejudice to actions taken under said order.

**Schedule No. 01**

- A. Chief Secretary or any Officer of the Western Provincial Council acting under delegated powers shall before making appointments notify the Secretary to the Public Service Commission of Western Province.
- B. Chief Secretary or any Officer of the Western Provincial Council acting under delegated powers, shall before transfer of officers on grounds of exigencies of service, obtain the concurrence of the Secretary to the Public Service Commission of Western Province.
