SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Eran Wickramaratne, Acting Minister of Finance and Mass Media, the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the list of commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 06 months commencing from May 08, 2018 subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette* Notification No. 2044/26 of 08.11.2017 in respect of Sprats and Dried Fish is rescinded with effect from May 08, 2018.
