THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, do hereby declare under Sub Section(1) of Section 5 of the Land Acquisition Act, that the Lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of land in the names and in the extents given below depicted in Advanced Tracing No. KE/GLG/2017/247 of 25/09/2016 prepared by Surveyor-General, situated in the Villages of Pitagaldeniya in the Grama Niladhari Division of No. 67, Narangoda Grama Niladhari Division in Kandupita Pattuwa North Minor Division in the Divisional Secretary's Division of Galigamuwa in Kegalle District in Sabaragamuwa Province are bounded as follows:

01. Lot 'A' – Kurukosgahamula Watta and Galketiye Watta – Extent: 0.0378 Hectare

North: Medalanda Hena; East: Remaining portion of Kurukosgahamula Watta and Galketiye Watta; South: Remaining portion of Kurukosgahamula Watta and Galketiye Watta and Lot B; West: Remaining portion of Kurukosgahamula Watta and Galketiye Watta.
