### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the province of that Act.

Ten (10) allotments of land depicted and in Advanced Tracing No. GA/GFG/2017/645 dated 15.11.2017, prepared by the Surveyor General situated in the Village called Deddugoda South Maitipe in the Divisional Secretary's Division of Galle Four Gravets in Galle District of Southern province and bounded as follows:

**01. Lot A – Extent: 0.0006 Hectare**

North: Land and Canal claimed by A. Manamperi; East: Road; South: The Bus Station, Lot B, Bombecasel Canal and Road; West: The Bus Station.

**02. Lot B – Extent: 0.0065 Hectare**

North: Road and Lot A; East: Bombecasel Canal; South and West: The Bus Station.

**03. Lot C – Extent: 0.0003 Hectare**

North: Bombecaselwatta claimed by P.G. Sisira Kumara and Lot D; East: Bombecasel Canal; South: Bombecaselwatta claimed by Siththi Aseek and Bombecasel Canal; West: Bombecaselwatta claimed by M. G. M. Mishraf.

**06. Lot F – Belekmananaththe Addarawatta – Extent: 0.0004 Hectare**

North: Belekmananaththe Addarawatta which the claimant could not be traced; East: Belekmananaththe Addarawatta which the claimant could not be traced and Bombecasel Canal; South and West: Bombecasel Canal.

**07. Lot G – Belekmananaththe Addarawatta – Extent: 0.0005 Hectare**
