### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, do hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Forty six (46) Allotments of land depicted and in Advanced Tracing No. GA/GFG/2017/826 dated 08.11.2017 prepared by the Surveyor General situated in the Village called Deddugoda North in the Divisional Secretary's Division, of Galle Four Gravets in Galle District, of Southern Province and bounded as follows :
