**THE MOTOR TRAFFIC ACT (CHAPTER 203)**

REGULATIONS made by the Minister of Transport and Civil Aviation under Section 237 of the Motor Traffic Act (Chapter 203) read with Section 128A of the aforesaid Act.

**Regulations**

1. These regulations may be cited as the Motor Traffic (Public Service Motor Tricycle) Regulations.
2. These regulations shall be applicable to every person who obtains a driving license valid for motor tricycle after these regulations come into operation and uses or adapts to be used or keeps such motor tricycle for the carriage of passengers for a fee or reward (hereinafter referred to as “person to whom these regulations apply”).
3. No person to whom these regulations apply shall drive a public service motor tricycle, except under special endorsement on the license endorsed in that behalf by the Commissioner-General of Motor Traffic (hereinafter referred to as the “Commissioner-General”).
4. Every person who desires to apply for an endorsement under regulation 3 shall -
  - (a) be not less than the age of thirty-five years and not more than the age of seventy years ; and
  - (b) have at least a period of two years' driving experience after obtaining the driving license for the motor tricycle



5. Every application for an endorsement under regulation No. 03 shall be made to the Commissioner-General substantially in the form set out in the Schedule hereto and shall be accompanied by-

- (a) a medical certificate issued by the National Transport Medical Institute or any other institution authorized by the Commissioner-General ;
- (b) a certificate of a training course designed, approved and conducted by the Commissioner-General or such training course conducted by an institution authorized by the Commissioner-General ;
- (c) A police report, confirming that the applicant is not an Island Registered Criminal ; and
- (d) a fee of rupees two thousand

6. A person to whom these regulations apply shall be disqualified from being a driver of a public service motor tricycle if he has been registered as an Island Registered Criminal under the Prevention of Crimes Ordinance (Chapter 22).

7. In this regulation-

“motor tricycle” shall have the same meaning as specified in the Motor Traffic Act (Chapter 203) ; and

“public service motor tricycle” means any motor tricycle used or adapted to be used or kept for the carriage of passengers for a fee or reward.
