I, hereby give notice under Sub section (1) of the Section 07 of the land Acquisition Act as amended by the land Acquisition (Amendment) Act, No.28 of 1964, that Government intends to acquire the following land which is required for resettlement of persons displaced by landslides in 2016 in Bulathkohupitiya Divisional Secretary's Division.
