THE LAND ACQUISITION ACT (CHAPTER 460) AS
AMENDED BY THE LAND ACQUISITION
(AMENDMENT) ACT, No. 28 OF 1964

Notice under Section 7

I hereby give notice, under Sub-section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose.

Description of the Land or servitude to be Acquired :

Allotment of land called in extent 0.6395 of Hectare, 3.2362 of Hectare shown as Lot 1 in Tri. 535 dated 07.07.2018 prepared by the Surveyor General. Situated in with in the Pradeshiya Sabah limits of Trincomalee No. 243F Thirukadaloor Grama Niladhari Division, Divisional Secretariat Division of Town and Gravets, Trincomalee District and bounded as follows.

Lot No. 320 – Extent of the Land: 0.6395 Hectare.

North by: Lots 26 and 25; *East by:* Lots 25, 26, 25, 322 and 321; *South by:* Lot 321 and North Coast Road; *West by:* North Coast Road and Lots 26 and 25.
