IMPORTS AND EXPORTS (CONTROL) ACT, No. 1 OF 1969

REGULATIONS

1. These Regulations may be cited as the Imports and Exports (Control) Regulations No. 09 of 2020.
2. The following items specified under HS Headings and HS Codes appearing in Column I and II and its corresponding entries appearing in Column III and IV shall be inserted to the **Schedule I** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017 as amended by the *Gazette Extraordinary* No. 2076/4 dated 18 June 2018, *Gazette Extraordinary* No. 2143/36 dated 03 October 2019, *Gazette Extraordinary* No. 2152/63 dated 06 December 2019, *Gazette Extraordinary* No. 2176/19 dated 22 May 2020, *Gazette Extraordinary* No. 2182/10 dated 30 June 2020 and *Gazette Extraordinary* No. 2189/4 dated 17 August 2020.
