CIVIL AVIATION ACT, No. 14 OF 2010

REGULATIONS made by the Minister of Tourism under Section 117(2)(q) of the Civil Aviation Act, No. 14 of 2010.

Regulations

The charges for the use of Aerodromes at the Bandaranaike International Airport (BIA), Mattala Rajapaksa International Airport (MRIA) and Colombo International Airport Ratmalana Regulations, published in the *Gazette Extraordinary* No. 1869/33 of July 02, 2014 is hereby amended as follows: -

- (1) in regulation 1 thereof, by the substitution for the words “Ratmalana Airport (RMA)” of the words “Colombo International Airport Ratmalana (CIAR)”;



(2) in regulation 3 thereof-

- (a) by the renumbering of that regulation as sub-regulation (1) thereof;
- (b) by the substitution for the words “BIA, MRIA and RMA” of the words “Bandaranaike International Airport (BIA), Mattala Rajapaksa International Airport (MRIA) and Colombo International Airport Ratmalana (CIAR)”;
and
- (c) by the insertion immediately after renumbered sub-regulation (1) of the following new sub-regulation:-

“(2) Notwithstanding anything to the contrary in this regulation a scheduled international airline shall be exempted from the payment of landing and parking charges at the airports specified in the table to this sub-regulation for a period of one year with effect from 08.09.2020.

(3) by the repeal of regulations 4,5 and 6 thereof and the substitution therefor of the following regulation: -

“4. In these regulations, unless the context otherwise requires-

“Act” means Civil Aviation Act, No. 14 of 2010;

“Aerodrome” shall have the same meanings as in the Act;

“Scheduled International Airline” means an airline authorized to operate scheduled international air services; and

“Statutory Service Provider” means the statutory service provider appointed under section 6(3)(a).
