2. **Description of the Land.**— The allotments of lands depicted in below names and extents in the Advance Tracing No. Ka/BLT/18/48 dated 02.03.2018 prepared by the Surveyor General, situated in the Village called Thennahena in the Divisional Secretary's Division of Bulathsinhala in Kalutara District of Western Province and bounded as follows:
