1. Whatsoever mentioned under the Orders on Motor Traffic Fees 2011 published in the *Extraordinary Gazette* No. 1730/18 dated 3rd of November 2011 and Orders on Motor Traffic Fees 2013 published in the *Extraordinary Gazette* No. 1808/11 dated 30th of April 2013 made by the Minister in charge of the subject of transport under Western Provincial Motor Traffic Statute No. 07 of 1991, prior to effective date of these orders, the fees under Schedule vi, vii and Section 12 and 13 of Schedule ix under the Orders published in the *Extraordinary Gazette* of the Democratic Socialist Republic of Sri Lanka No. 2306/02 dated 14th of November 2022 made under Section 237 of the Motor Traffic Statute by the Minister of Transport shall be fees to be paid in relation to the Western Provincial Council Fund with effect from the date of operation of these Orders.
2. In the event of any inconsistency between Sinhala, English and Tamil texts of these orders, the Sinhala text shall prevail.
