Notification

IT is hereby notified that the notification issued by me in the exercise of powers vested in me under paragraph (1) (a) of Article 44 of the Constitution of the Democratic Socialist Republic of Sri Lanka and published in the *Gazette Extraordinary* No. 2281/41 of May 27, 2022 and amended by the notification published in the *Gazette Extraordinary* No. 2283/34 dated June 09, 2022, is further amended with effect from June 24, 2022 in the manner set out in the schedule below.

- (1) With reference to the Heading No. “27. Minister of Technology and Investment Promotion” of the said notification, as follows :-
- (a) The Heading as “27. Minister of Technology”;
- (b) By substitution of the following item, instead of Item 1 in Column I, thereof;
1. Formulation, implementation, monitoring and evaluation of policies, programmes and projects, in relation to the subject of Technology, and those subjects that come under the purview of Departments, Statutory Institutions and Public Corporations listed in Column II based on the national policies implemented by the government, and in accordance with the policy statement “Vistas of Prosperity and Splendour”
