- (1) The Church called Paththawaththei St. Philip Neris situated at Latitude 09° 48' 00"931 and Longitude 79° 59' 45.388 E and belonging to Paththawaththei Village in the Grama Niladhari Division No. J/221, Paththawaththei in the Divisional Secretary's Division, thellipalei (Walikamam North) in Jaffna District in North Province.
- (2) Stone pillars, Pillar Inscription and stone *Siripathul* (Foot print of Lord Buddha) etc. found at the premises of Bodhirukkharama, Ipalogama belonging to Ipalogama village in Grama Niladhari Division No. 167, Ipalogama in the Divisional Secretary's Division, Mahawa, in Kurunegala District in North Western Province.

- (1) Ancient Image House at the premises of Sri Kadaliwanarama Vihare, Keselwatte situated in Polwattahena in the Grama Niladhari Division of Polwattahena in Opanayake Divisional Secretary's Division in Ratnapura District, Sabaragamuwa Province.
- (2) Emitiyagoda Walawwa situated at the venue known as Walawwatte in Emitiyagoda in the Grama Niladhari Division No. 599 of Emitiyagoda in Godakawela Divisional Secretary's Division in Ratnapura District, Sabaragamuwa Province.

- (9) Cave cover with pre-historical factors at the venue known as Belingala *alias* Higuralkanda situated in Dikella village in the Grama Niladhari Division No. 120 of Hinguralakanda East in Dehiowita Divisional Secretary's Division in Kegalle District, Sabaragamuwa Province. (North Latitudes 06° 91' 7360" N and East Longitudes 080° 30' 9614" E)

- (12) The Drip ledge cave, Chethiya, Drain and flight of stairs inscribed on the natural rock, ancient residence of monks in the premises of Siri Sangabo Sri Buwanekaba Vihare situated in Padidora village in the Grama Niladhari Division No. 18 A of Kappagoda in Mawanella Divisional Secretary's Division in Kegalle District, Sabaragamuwa Province. (North Latitudes 7° 135 N and East Longitudes 80° 2620 E)
- (13) The Drip ledge temple in the premises of Galge Cave Vihare in Aluthnuwara village in the Grama Niladhari Division No. 27 of Aluthnuwara in Mawanella Divisional Secretary's Division in Kegalle District, Sabaragamuwa Province.
- (14) The Drip ledge cave temple in the premises of Sri Revatha Pirivena *alias* Udawatte Vihare situated in Udamakadawara village in the Grama Niladhari Division No. 25 B of Udamakadawara in Mawanella Divisional Secretary's Division in Kegalle District Sabaragamuwa Province.

(North Latitudes 06° 01' 04.497"N and East Longitudes 80° 47' 13.994" E)
- (17) The mound of Stupa and the venue with other ancient construction evidences in the land known as Weheragodella situated in Karagahawela village in the Grama Niladhari Division No. 195 of Karagahawela in Angunakolapelessa Divisional Secretary's Division in Hambantota District, Southern Province. (North Latitudes 6° 12' 13.675" N and East Longitudes 80° 52' 39.337"E)
- (18) The mound of ancient Stupa in the land known as Weheragodella situated in Netoplitiya village in the Grama Niladhari Division Netolpitiya - North in Tangalle Divisional Secretary's Division in Hambantota District, Southern Province. (North Latitudes 06° 04' 50.752" N and East Longitudes 80° 50' 55.209" E)
- (19) The lamp post which burns for all twelve months, rock inscription and the area in extent of 4m around the same, flight of steps and the area in extent of 6m around the same at the premises of Seelawathi Parwatha Vihare in Modarawana village in the Grama Niladhari Divisions of Modarawana North and Modarawana South in Okewela Divisional Secretary's Division in Hambantota District, Southern Province (North Latitudes 6° 08' 23.7" N and East Longitudes 80° 42' 24.1" E)
- (20) The ancient Image House with paintings in the premises of Purwarama Raja Maha Vihare situated in Kurumbure village in the Grama Niladhari Division No. 450 B of Bambarenda North in Dikwella Divisional Secretary's Division in Matara District, Southern Province.
- (21) The ancient Image House with paintings in the premises of Sri Bodhirukkarama Vihare situated in Hallala village in the Grama Niladhari Division No. 375 of Hallala in Welipitiya Divisional Secretary's Division in Matara District, Southern Province.
- (22) The ancient Chieftain's mansion in the land known as Mullegewatte and the premises bounded in the extent of 5m on the North and South, in the extent of 10m on the East and by a boundary wall on the West related to lot No. 01 depicted in the Plan No. 1908 of the venue bearing the Assessment No. 216 on Polathumodara Road in denipitiya village in the Grama Niladhari Division of Denipitiya in Weligama Divisional Secretary's Division in Matara District, Southern Province. - (26) Ancient frescos and sculptures in the Image House and the ancient Chetya at the premises of Kachchiwatte

Purana Vihare situated in Magalla village in the Grama Niladhari Division No. 99 C of Magalla in Four Gravette Divisional Secretary's Division in Galle District, Southern Province.

- (27) Ancient Gana Devi Kovil building of Unawatuna situated in Unawatuna village in the Grama Niladhari Division of Unawatuna West in Habaraduwa Divisional Secretary's Division in Galle District, Southern Province. (North Latitudes 6° 01' 06" N and East Longitudes 80° 14' 88" E)

- (28) Ancient Image House and the middle part of the Dhamma Preaching Hall of Kalalpitiya Purana Vihare situated at Kalalpitiya village in the Grama Niladhari Division of Kalalpitiya in Ukuwela Divisional Secretary's Division in Kandy District, Central Province.
- (29) Image House and the Dhamma Preaching Hall in the premises of Watagoda Purana Vihare situated in Hippola village in the Grama Niladhari Division of Batagalla in Pathahewaheta Divisional Secretary's Division in Kandy District, Central Province. (North Latitudes 7° 14' 55" N and East Longitudes 80° 41' 56" E)
- (30) Two ancient Image Houses and residence of monks in the premises of Sagama Raja Maha Vihare situated in Sagama village in the Grama Niladhari Division of Bootawaththa South in Pathahewaheta Divisional Secretary's Division in Kandy District, Central Province.

- (34) Ancient wooden Bridge situated in the premises of Bogoda Raja Maha Vihare in Bogoda village in the Grama Niladhari Division No. 76 of Bogoda in Haliela Divisional Secretary's Division in Badulla District, Uva Province. (North Latitudes 7° 00' 29.7" N and East Longitudes 80° 59' 46.8 E)
- (35) Ancient Pattini Devale and other ruins situated at the venue known as Bogahawatte in Ampitiya village in the Grama Niladhari Division of Kirawanagama in Haldummulla Divisional Secretary's Division in Badulla District, Uva Province. (North Latitudes 6° 44' 09.88" N and East Longitudes 80° 56' 26.48" E)
- (36) The Devale situated in the premises of Sri Kataragama Devale in Haputale village in the Grama Niladhari Division Haputale in Haputale Divisional Secretary's Division in Badulla District, Uva Province. (North Latitudes 6° 45' 02.2" N and East Longitudes 80° 57' 28.7" E)
- (37) The ancient building known as Wilson Bungalow situated in the premises of Sri Piyatissa, pirivena of Vidurapola in Gawarammana village in the Grama Niladhari Division Gawarammana in Welimada Divisional Secretary's Division in Badulla District, Uva Province. (North Latitudes 6° 54' 01.66" N and East Longitudes 8° 51' 47.84" E)
