Rules under Sections 171 and 184 of the pradeshiya sabhas act no. 15 of 1987

SINCE it is necessary to make provision for all matters related or incidental to the financial and administrative affairs of Pradeshiya Sabhas, the Provincial Council (Consequential) Act No. 12 of 1989 to be read with Sections 171 and 184 of the Pradeshiya Sabhas Act No. 15 of 1987 to me under Section 2 according to the assigned powers, Governor of Sabaragamuwa Province A. A. C. J. Rajaratna, hereby declares that the Public Sector Accounting Standard of Sri Lanka for Local Government Authorities - 2017 published by the Institute of Chartered Accountants of Sri Lanka to streamline the administration and financial management of Pradeshiya Sabhas should be applied to all Pradeshiya Sabhas in Sabaragamuwa Province.

17.04.1989 and published in the *Gazette* of the Democratic Socialist Republic of Sri Lanka bearing number 554/5, these accounting standards should be effective from 01 January 2025 for the areas of administration and financial control not covered by the Pradeshiya Sabhas (Finance and Administration) rules of 1988.
