The Board of Investment of Sri Lanka (Fees and Charges) Rules published in *Gazette Extraordinary* No.1595/15 dated 31<sup>st</sup> March 2009; No.1634/13 dated 28<sup>th</sup> December 2009; No.1737/13 dated 22<sup>nd</sup> December, 2011, and No.1789/21 dated 19<sup>th</sup> December, 2012; No.1947/27 dated 30<sup>th</sup> December, 2015; No.2025/43 dated 30<sup>th</sup> June, 2017; No.2104/18 dated 01<sup>st</sup> January, 2019, No.2260/77 dated 01<sup>st</sup> January 2022 and No.2273/77 dated 1<sup>st</sup> April, 2022 the matters and the amounts specified in the respective Columns I and II are hereby further amended as follows :-
