Notice under Section 7

I do hereby give public notice, under sub Section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that land in the area described below is required for a public purpose and the government is intending to acquire it:

Description of the land intended for acquisition:

The Public purpose here is the acquisition of land for the Kirioya Elephant Pass Development Project.

The allotment of land is mentioned in the Plan No. 120230, Zone No - 01, Sheet No. 2, prepared by the Surveyor General and shown as Lot Nos 1, 2, 3 and 4 in the Survey Plan dated 05.08.2025 and Plot No. 8702

mentioned in the අ.භ.පි.25 Interim Plot No 192, Sheet No. 203 of the plan dated 31.07.2025, which is situated in the Village of Kirioya in the Grama Niladhari Division of No. 01 Kirioya under the Elahera Divisional Secretary's Division in Polonnaruwa District, North Central Province.
