## **Land Acquisition Notices**

#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below is needed for a public purpose and will be acquired under the provisions of that Act.

The alloments of below mentioned land, Lots 'A' to 'D' (No. 1 to 4), total extent of about 0.8456 Hectare, depicted in Tracing No. GA/DSO/2019/644 dated 16.12.2019, prepared by the Superintendent of Surveys, situated in the Village of Maththumagala, in the Grama Niladhari Division of No. 177, Maththumagala, in the Divisional Secretary's Division

of Wattala, in Gampaha District, in Western Province and bounded as follows:

#### 01. Lot 'A' – Jawage Kotuwa - Extent: 0.0566 Hectare

North: The land of which claimant and the name of the land cannot be found; East: The balance portion of this land & Road (Road Development Authority); South: Road (Road Development Authority); West: The land of which claimant and the name of the land cannot be found.
