SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2 and 5

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Anura Kumara Dissanayake, Minister of Finance, Planning and Economic Development of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column (I) of the Schedule hereto a Special Commodity Levy at the rate specified in corresponding entry in Column (II) of that Schedule.

2. By virtue of the powers vested in me under Section 5 of the Special Commodity Levy Act, No. 48 of 2007, I do hereby order to waive-off the balance amount after collecting Rs. 10/kg from the applicable Special Commodity Levy of Rs. 320/kg on importation of dehydrated coconut chips with outer brown testa (excluding copra) classified under HS Code of 0801.11.90 for the purpose of domestic production of coconut oil under the import licence requirement subject to recommendation of the Coconut Development Authority.
3. These Orders, under Section 2 and 5 of the Special Commodity Levy Act, No. 48 of 2007, shall be effective commencing from October 10, 2025 to March 31, 2026 subject to provisions of Sub Section (3) of Section 2 of the said Act.
