#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are required for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands described in below names and extents in the Advance Tracing No. Co/KLN/2022/477 dated 21.12.2022, prepared by the Surveyor General, situated in the Village of Thalahena (within the Urban Council limits of Kolonnawa) in the Grama Niladhari Division No. 502C of Rajasinhagama in the Divisional Secretary's Division of Kolonnawa in the District of Colombo in Western Province and boundaries of lands as follows:
