Thence a line drawn along the Eastern boundary of No. 102D Ambagolla Grama Niladhari Division until it meets Northern boundary of No. 102A Radaliyadda Grama Niladhari Division (5).

East :

From the last mentioned point a line drawn Northeastward along the Northern boundary of No. 102A Radaliyadda Grama Niladhari Division until it meets Eastern Boundary of No. 102A Radaliyadda Grama Niladhari Division (6), thence a line drawn Southward and Southeastward along the Eastern boundary of No. 102A Radaliyadda Grama Niladhari Division until it meets Southern boundary of No. 102A Radaliyadda Grama Niladhari Division and Eastern boundary of No. 101C Lindakumbura Grama Niladhari Division (7), thence a line drawn Southward and Southeastward along the Eastern boundary of No. 101C Lindakumbura GN Division until it meets Eastern boundary of No. 99B Dehiattawela Grama Niladhari Division (8).

South :

From the last mention point a line drawn Southeastward, Southward along the Eastern boundary of No. 99B Dehiattawela Grama Niladhari Division until it meets southern boundary of No. 99A Kanulwela Grama Niladhari Division (9), thence a line drawn Southwestwards, Northwestward and westward along the Southern boundary of No. 99A Kanulwela Grama Niladhari Division until it

West :

From the last mention point a line drawn Southwestward and Northward along the Southern boundary of No. 98A Ethanawatta Grama Niladhari Division until it meets Southern boundary of No. 100E Hewelwela Grama Niladhari Division (11), thence a line drawn Westward, Southwestward and Northward along the Southern boundary of No. 100E Hewelwela Grama Niladhari Division until it meets Southern Boundary of No. 100F Badullagammana Grama Niladhari Division (12), thence a line drawn Northwestward and Northeastward along the Western boundary of No. 100F Badullagammana Grama Niladhari Division until it meets the starting point, located at Western boundary of No. 102C Wegama South Grama Niladhari Division.
