**UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 27(1)(b) read with Section 25A**

BY virtue of powers vested in me by section 27(1)(b) read with section 25A of the Universities Act, No. 16 of 1978, I, Dr. Harini Amarasuriya, the Minister of Education, Higher Education and Vocational Education having obtained a report under Section 70C of the aforesaid Act, in respect of the Sri Lanka Institute of Information Technology (Guarantee) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number GL 24, being recognized as a Degree Awarding Institute, do by this Order, amend the Schedule II to the Order made under the said Act and published in *Gazette Extraordinary*, No. 2415/20 of December 16, 2024, by the addition immediately after entry “Bachelor of Science Honours in Psychology” appearing in *Column I* and its corresponding entry in *Column II* thereof, of the entries specified under *Column I* and *II* respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto :-

**SCHEDULE I**

**CONDITIONS**

Sri Lanka Institute of Information Technology (Guarantee) Limited shall, when admitting students for the degree programme specified in Schedule II hereto in respect of :-

1. Bachelor of Science Honours in Quantity Surveying with a minimum of 120 Credits (SLQF Level 6), adhere to the minimum entry qualification of;
  - 1.1. Simple pass (S) for at least one (01) subject in category (a) and two (02) subjects in category (b) in one and the same sitting at the G.C.E (Advanced Level) Examination conducted by the Department of Examination of Sri Lanka or equivalent qualification



- (a) i. Combined Mathematics  
ii. Higher Mathematics
- (b) i. Accounting  
ii. Economics  
iii. Business Statistics  
iv. Business Studies  
v. Physics  
vi. Chemistry  
vii. Information & Communication Technology

And

- 1.2. Two (02) Credit passes (C) for Mathematics and English language and a simple pass (S) for Science subject at the G.C.E. (Ordinary Level) Examination conducted by the Department of Examination of Sri Lanka or equivalent qualification.
2. Bachelor of Science Honours in Biomedical Science with a minimum of 120 Credits (SLQF Level 6), adhere to the minimum entry qualification of three (03) simple passes (S) in Biological Science stream in one and the same sitting at the G.C.E (Advanced Level) Examination conducted by the Department of Examination of Sri Lanka or equivalent qualification.
3. Master of Science in Artificial Intelligence with a minimum of 60 Credits (SLQF Level 10), adhere to the minimum entry qualification of;
- 3.1. A Bachelor of Science Degree in Computer Science, Computer Engineering or Data Science from a University or institute recognized by the University Grants Commission or Ministry in charge of the subject of Higher Education; Or
- 3.2. A Bachelor's Degree in a relevant field from a University or institute recognized by the University Grants Commission or Ministry in charge of the subject of Higher Education with one year experience in a related field.
4. Sri Lanka Institute of Information Technology (Guarantee) Limited is recognized to offer the degrees specified in Schedule II hereto subject to the five (5) year periodic review conducted by the Specified Authority.
