I hereby notify that the Government intends to acquire the following land for the fourth phase of Urban Development Activities including Solid Waste Management Project under Sub section (1), Section 7 of Land Acquisition Act (Chapter 460) as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964.

#### The particulars of the land intend to acquire:
