THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kurugamage Don Lal Kantha, Minister of Agriculture, Livestock, Land and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude described below is required for a public purpose and will be acquired under the provisions of that Act. Column 11 details The land from which the said condition is achieved.

1. **Description of the Servitude.**– Acquiring the Right of Servitude of a portion of land for Thalatuoya Service Reservoir of Kundasale Haragama Water Supply project and access road of the pump house and plumbing.
