**THE LAND ACQUISITION ACT (CHAPTER 460)**

Notice under Section 7

I hereby give notice for information of the public, that the notice EOG 08 - 0019 in the *Gazette* No. 2343/27 and dated 02.08.2023 published under Section 7 of the Land Acquisition Act should be amended as follows:

*Description of the land/servitude to be acquired:*

Two allotments of land in total extent of about 0.0197 Hectare, bearing Lot Nos. 235 and 236 in the Surveyor General's Cadastral Map No. 420214 dated 31.08.2022 and in sheet No. 11, block No. 01, situated at the Village of Idangapola, in Narampola Grama Niladhari Division, No. 725, in the Divisional Secretary's Division of Mallawapitiya, in Kurunegala District, North Western Province and bounded as follows:
