I hereby give notice under sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land as it is needed to acquire additional allotments of land for the Laying of Pipe Lines to Carry Untreated Water under Kundasale - Haragama Water Supply Project.
