CUSTOMS NOTIFICATION

The Customs Ordinance (Chapter 235)

ORDER UNDER SECTION 10 (A)

BY virtue of the powers vested in me under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act No. 83 of 1988, I, Anura Kumara Dissanayake, Minister of Finance, Planning and Economic Development of the Democratic Socialist Republic of Sri Lanka, do by this Order to amend the Order issued under *Extraordinary Gazette* No. 2421/43 dated 31st January 2025, do by this Order levy on imported goods specified in the Schedule hereto, a surcharge at the rate of 50% on applicable Customs Import Duty, both General and Preferancial basis, with effect from 29 April, 2025, to 31st January 2026.
