## The Land Acquisition Act (Chapter 460)

Notice under Section 7

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, that the Government has acquired the allotments of the lands-for the widening and development of Ambalan Ela which runs across the Bus Route No. 120, under Weras Ganga Storm Water Drainage and Environment Improvement Project.

Description of the land to be acquired:

An allotment of land depicted as Lot No. 01 in Sheet No. 06, Block No. 03 of the Cadastral Map No. 521239 dated 10.04.2025 prepared by the Surveyor General, situated in the Village called Katuwawala (Ward No. 09 of Katuwawala, within the Urban Council limits of Boralesgamuwa) in the Grama Niladhari Division No. 578 A of Katuwawala in Divisional Secretary's Division of Kesbewa in Colombo District of the Western Province and bounded as follows:
