**NATIONAL POLICE COMMISSION**

The delegation of powers by the National Police Commission in terms of Article 155J of the Constitution of the Democratic Socialist Republic of Sri Lanka.

The National Police Commission is hereby specifically ordered to amend the provisions published under No. 4 and 8, and to remove the provisions published under No. 5 mentioned in the Schedule of the *Extraordinary Gazette Notification* of No. 2341/51 and dated 20.07.2023 delegation of powers made by the National Police Commission in accordance with the section 155j of the constitution.

02. The other provisions of the said *Extraordinary Gazette* notification No. 2341/51 and dated 20.07.2023 on Delegation of Powers made by the National Police Commission is remain unchanged.

03. It is hereby declared that this delegation of powers shall be in operation with effect from 01<sup>st</sup> June 2025.

04. In the event of any inconsistency between Sinhala, Tamil and English texts, the Sinhala text shall prevail.
