UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 25A

BY virtue of the powers vested in me by section 25A of the Universities Act, No. 16 of 1978, I, Dr. Harini Amarasuriya, the Minister of Education, Higher Education and Vocational Education having obtained a report under section 70C of the aforesaid Act, in respect of Sri Lanka Institute of Information Technology (Guarantee) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number GL 24, being recognized as a Degree Awarding Institute, do by this Order and subject to the conditions specified in schedule I hereto, recognise the branch located at Balagolla, Kengalla, Kandy (Kandy Branch) of Sri Lanka Institute of Information Technology (Guarantee) Limited, to offer the degrees specified in Column I of the Schedule II hereto, of which the abbreviation is set out in the corresponding entry in Column II of the Schedule II hereto, for the purpose of developing Higher Education therein :-

SCHEDULE I

CONDITIONS

1. Sri Lanka Institute of Information Technology (Guarantee) Limited - Kandy Branch, shall be recognized to offer the Degrees specified in Schedule II hereto, subject to the five (5) year review conducted by the Specified Authority from the date of publication of this Order.
2. Sri Lanka Institute of Information Technology (Guarantee) Limited - Kandy Branch, shall conduct the degree programmes specified in Schedule II hereto, only at Balagolla, Kengalla, Kandy.



3. Sri Lanka Institute of Information Technology (Guarantee) Limited - Kandy Branch shall, when admitting students for the degree programmes relevant to the degree specified in Schedule II hereto, adhere to the minimum entry qualifications approved in respect of therefor, by the Specified Authority.
