##### LAND ACQUISITION ACT (CHAPTER 460)

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition (Amendment) Act No. 28 of 1964 that the Government intends to acquire the following land which is required for the construction of a 2000 cubic meter underground reservoir at Rambawewa and a 450 cubic meter water tower for the proposed Katupotha - Bamunakotuwa - Panduwasnuwara Water Supply Project.
