Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are required for a public purpose and will be acquired under the provisions of that Act.

The allotments of land described as following names and extents, depicted in the Advanced Tracing No. NU/AMB/2022/418 dated 24.02.2023, prepared by the Surveyor General, situated in the Village of Polpitiya in the Minor Division of Ambagamuwa Korale in the Divisional Secretary's Division of Ambagamuwa Korale in the District of Nuwara Eliya, Central Province and bounded as follows:

01. Lot 'A' – Broadlandwatta – Extent: 0.0414 Hectare

North: Broadlandwatta claimed by the State and Road; East: Broadlandwatta claimed by the State, Road and Broadlandwatta of which the claimant cannot be found; South: Broadlandwatta of which the claimant cannot be found; West: Lot B and Broadlandwatta claimed by the State.

02. Lot 'B' – Broadlandwatta – Extent: 0.0282 Hectare

North: Lot D, Broadlandwatta claimed by the State and Lot B; East: Lot B; South: Broadlandwatta of which the claimant cannot be found; West: Broadlandwatta of which the claimant cannot be found and Lot D.

04. Lot 'D' – Broadlandwatta – Extent: 0.0281 Hectare

North: Broadlandwatta claimed by the State and Road; East: Broadlandwatta claimed by the State and Lot C; South: Lot C, Broadlandwatta of which the claimant cannot be found and Broadlandwatta claimed by the State; West: Broadlandwatta claimed by the State.
