THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Kuragamage Don Lal Kantha, Minister of Agriculture, Livestock, Lands and Irrigation do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are required for a public purpose and will be acquired under the provisions of that Act.

Acquisition of allotments of land (Kolongaswatta) for the construction of Kolongaswatta Service Reservoir of Kundasale Haragama Water Supply Project.
